Students wishing to travel should complete and submit the Student Travel Authorization Request ([click here to access the Student Travel Authorization Request form](#)). The travel form should include the specific purpose of the student's travel and any anticipated expense along with approvals from the Department Chair, Dean and Vice-president under whose auspices the student is traveling. If the travel is to be outside of the country, the traveler must also follow the requirements related to international travel. Travel expenses for students should be submitted following regular University out-of-state travel regulations regardless of whether the travel is in-state or out-of-state.

Although approval procedures vary among University division, all travel approvals must take place PRIOR to the actual purchase of tickets, conference registration, etc. as well as participation in the planned travel activity whether it is domestic travel or international travel. Please check with your appropriate administrative units for the timely filing deadlines that may apply for pre-approval of such travel.

Documentation

Receipts, other than meals, and any other documentation of the total costs of the trip (including any prepaid expenses) must be attached to and submitted along with the travel expense report. Documentation must include information detailing meals included in a registration fee. This would normally be the complete conference agenda or similar conference registration information that, at a minimum, includes daily meeting schedules.
